**EVACUATION ORDER  
G61316 WILDFIRE  
July 10, 2021 AND TIME 9:00am**

Pursuant to [Section 12 (1) of the BC Emergency Program Act / Band Council] an **Evacuation Order** has been issued by [Tsay Keh Dene First Nation] due to immediate danger to life safety caused by: Wildfire.

Members of the [local police department and other agencies] and other applicable agencies will be expediting this action.

The Evacuation Order is in effect for the following areas:

Mesilinka Indian Reserve No. 7 (known as BLACKPINE) is located at **56 20.080' N 125 14.943' W**.

**YOU MUST LEAVE THE AREA IMMEDIATELY**

**WHAT YOU SHOULD DO:**

- YOU MUST LEAVE THE AREA IMMEDIATELY AND REGISTER AT THE Reception center
- Persons who disregard the Evacuation Order and remain in the Evacuation Order Area do so at their own risk. The Tsay Keh Dene First Nation may be unable to assist anyone who remains in the Evacuation Order area.
- If you need transportation assistance from the area, advise the person providing this notice or call
- Shut off all gas and electrical appliances, other than refrigerators and freezers.
- Close all windows and doors.
- Close gates (latch) but do not lock.
- Gather your family and, if you have room, take a neighbour or someone needing transportation. Do not use more vehicles than you have to.
- Take critical items (medicine, purse, wallet, cell & charger and keys) only if they are immediately available. Take pets in pet kennels or on leash.
- Do not use the telephone unless you need emergency service.
