



EVACUATION ORDER

Pursuant to the Authority of the Council under Sections 81 and 88 of the Indian Act to evacuate these areas has been authorized in the interest of life and safety. An **Evacuation Order** has been issued by Little Shuswap Lake Band (LSLB) due to immediate danger to life safety caused by: **FLOODING**.

Members of the LSLB Emergency Management Program and other applicable agencies will be expediting this action.

The Evacuation Order is in effect for the following areas:

288 & 292 SCHOUTEN ROAD



YOU MUST LEAVE THE AREA IMMEDIATELY

WHAT YOU SHOULD DO:

- Follow the travel route provided and register with Andrea Stelter (250-318-5723)
- Shut off all gas and electrical appliances, other than refrigerators and freezers.
- Close all windows and doors.
- Close gates (latch) but do not lock.



- Gather your family and, if you have room, take a neighbour or someone needing transportation. Do not use more vehicles than you have to.
- Take critical items (medicine, purse, wallet, and keys) only if they are immediately available. Take pets in pet kennels or on leash.
- Do not use the telephone unless you need emergency service.

EVACUATION ALERT

SCHOUTEN ROAD

06/22/2022

An Evacuation Alert has been issued by Little Shuswap Lake Band at the Emergency Operations Centre (EOC) due to risk of **FLOODING**.

The BC River Forecast Centre has issued a Flood Watch for the Shuswap region including South Thompson River and its tributaries. Rivers in the region are flowing very high for this time year and are extremely vulnerable to an additional runoff at this point including weather events.

Because of the potential danger to life and health, the Little Shuswap Lake Band has issued an **Evacuation Alert** for the following areas:

- **IR#1 - Schouten Road**
- **IR#2 - Arnouse Lane**
- **IR#4 - Hilliam Road**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation; however you may receive limited notice due to changing conditions.

WHAT YOU SHOULD DO:

- Locate all family members and designate a meeting area outside the evacuation area, should an Evacuation Order be called while separated.
- Pack essential items such as government-issued ID, medications, eyeglasses, valuable papers (e.g. insurance, credit, and mortgage information), immediate care needs for dependents and, if time and space permits, keepsakes for quick departure.
- Prepare to move disabled persons, children and/or neighbours, if assistance is needed.
- Prepare to take pets with you and move livestock to a safe area (if possible).
- Arrange transportation for all your household members. Fill the gas tanks of personal vehicles. If transportation assistance is needed, call the LSLB Emergency Program Coordinator (Andrea Stelter 250-318-5723).
- Arrange accommodation for all members of the residence, if possible.
- Wait for an Evacuation Order to be issued before evacuating.
