EVACUATION ALERT AND REVISED ORDER

August 26, 2023 at 13:30 Hours

Pursuant to the *Emergency Program Act*, an Evacuation Alert has been issued by the Regional District of Central Okanagan Emergency Operations Centre (EOC) due to wildfire.

On August 21, 2023 at 21:30hrs an Evacuation Order was issued for properties in the Rainbow Road area. Due to improving conditions, the City of West Kelowna has **downgraded the following properties from an Order to an Evacuation Alert:**

A map of the area that has been downgraded to an Evacuation Alert is attached. This map also illustrates which areas remain on Evacuation Order.

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary because of the potential danger to life and health.

Residents will be given as much advance notice as possible prior to evacuation; however, you may receive limited notice due to changing conditions.

WHAT YOU SHOULD DO WHEN AN ALERT IS IN EFFECT

Upon notification of an ALERT, you should be prepared for the evacuation order by:

- Locating all family members or co-workers and designate a meeting place outside the evacuation area, should an evacuation be called while separated.
- Gathering essential items such as medications, eyeglasses, valuable papers (i.e. insurance), immediate care needs for dependants and, if you choose, keepsakes, photographs, etc. Have these items readily available for quick departure.
- Preparing to move any disabled persons and/or children.
- Moving pets and livestock to a safe area.
- Arranging to transport your household members or co-workers in the event of an evacuation order.
- Arranging accommodation for your family if possible. In the event of an evacuation, Reception Centres will be opened if required.
- Monitoring news sources for information on evacuation orders and location(s) of Reception Centres.
