NOTICE TO COMMUNITY MEMBERS OF AN EVACUATION ORDER

On **August 15, 2023 at 4:00 pm** the Lower Similkameen Indian Band Council issued a Declaration of a State of Local Emergency to implement an **evacuation order** for the Lower Similkameen Indian Reserve Lands and/or **Similkameen I.R No. 10** (Ashnola Village 739; 713 Ashnola Village; 721 Ashnola Village; 715 Ashnola Village; 708 Ashnola Village; 701 Ashnola Village; 704 Ashnola Village; 737 Ashnola Village; 729 Ashnola Village; 719 Ashnola Village; 741 Ashnola Village; 702 Ashnola Village; 710 Ashnola Village; 733 Ashnola Village; 712 Ashnola Village; 711 Ashnola Village; 124 Ashnola Village; 739 Ashnola Village; 730 Ashnola Village; 735 Ashnola Village; 128 Ashnola Village; 350 Ashnola Village;); Ashnola Road (440 Ashnola Road; 435 Ashnola Road; 425 Ashnola Road; 411 Ashnola Road; 445 Ashnola Road; 650 Ashnola Road; 660 Ashnola Road; 668 Ashnola Road; 670 Ashnola Road;); Paul Creek Road I.R No. 10 (750 Paul Creek Road; 510 Paul Creek Road; 321 Paul Creek Road; 111 Paul Creek Road;); due to being advised of the imminent danger of the Crater / Gillander Wildfire.

Due to this risk, all community members and visitors within the area defined above are to evacuate via the designated evacuation routes. Members of the Royal Canadian Mounted Police, other local police services of jurisdiction and/or other agencies responsible for response will be expediting the evacuation of the identified area on behalf of the Band Council.

All evacuees should:

- Meet at the designated safe place; and,
- Follow evacuation instructions and directions from the designated emergency management personnel identified to coordinate this evacuation; and,
- Take their grab-and-go bags they prepared during the evacuation alert; and
- Register with local Emergency Social Services and Reception Centre(s) located.
- once safely outside the community.

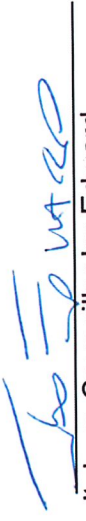
