### EVACUATION ALERT

#### CASPER CREEK FIRE

AUGUST 17 2023 AND TIME (19:50)

**An Evacuation Alert has been issued by BRIDGE RIVER INDIAN BAND.** Bridge River Indian Band is implementing an Evacuation Alert, at the Recommendation of BCWS, **due to the smoke, visibility and projected growth over the coming three (3) days.** This alert encompasses Highway 40 from the Dam to the Yalakom FSR, and east to Applesprings Creek.

Because of the potential danger to life and health, the **BRIDGE RIVER INDIAN BAND** has issued an **Evacuation Alert for the following areas:**

**Lillooet Pioneer Road and Antoine Creek residents**  
**(1901 Moha Road, 30320 Lillooet Pioneer Road)**

An Evacuation Alert has been issued to prepare you to evacuate your premises or property should it be found necessary. Residents will be given as much advance notice as possible prior to evacuation; however you may receive limited notice due to changing conditions.

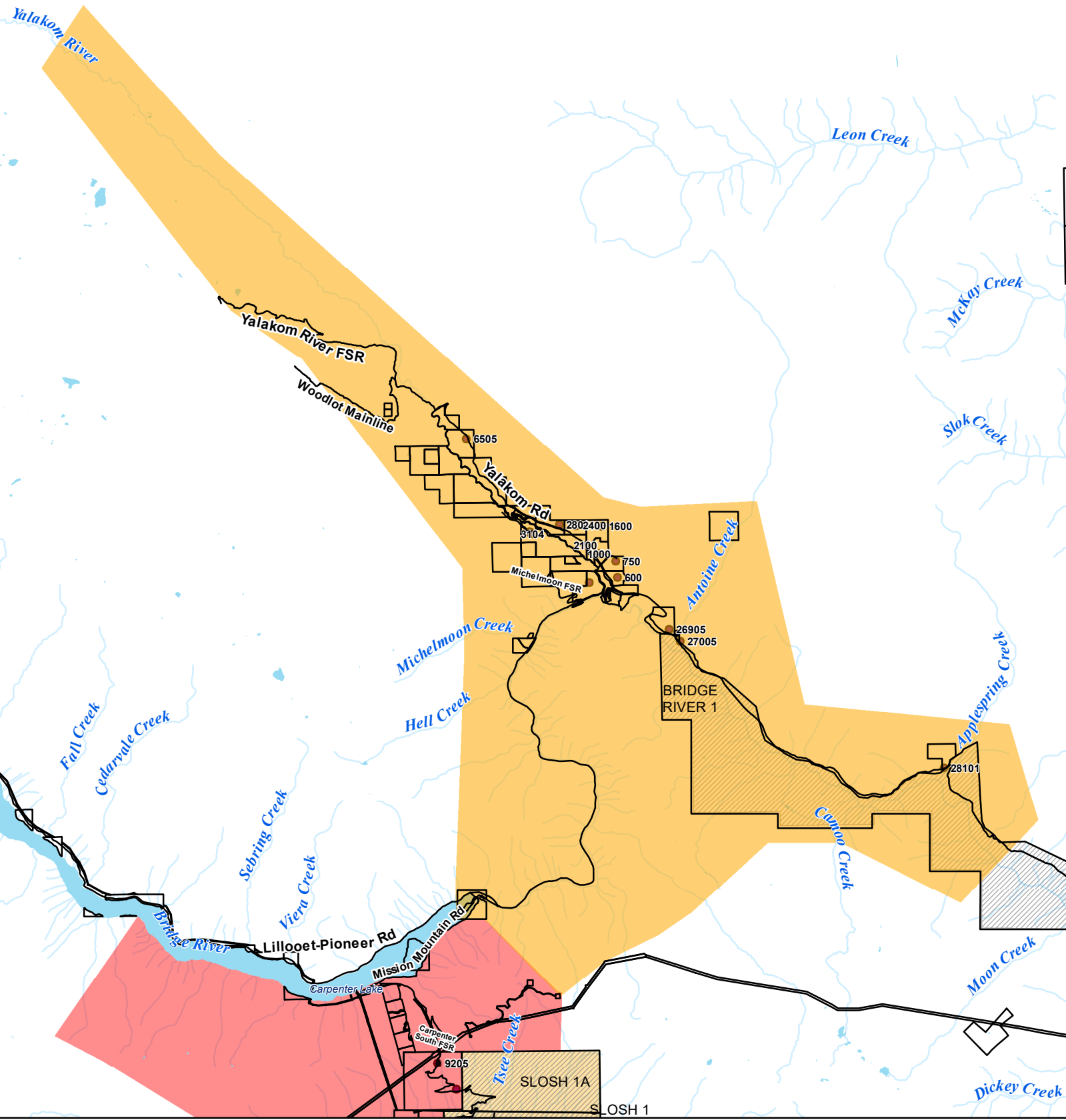
#### WHAT YOU SHOULD DO:

- Locate all family members and designate a meeting area outside the evacuation area, should an Evacuation Order be called while separated.
- Pack essential items such as government-issued ID, medications, eyeglasses, valuable papers (e.g. insurance, credit, and mortgage information), immediate care needs for dependents and, if time and space permits, keepsakes for quick departure.
- Prepare to move disabled persons, children and/or neighbours, if assistance is needed.
- Prepare to take pets with you and move livestock to a safe area (if possible).
- Arrange transportation for all your household members. Fill the gas tanks of personal vehicles. If transportation assistance is needed, call Moon Moore [250-256-3297] or Bridge River Indian Band 250-256-7423.
- Arrange accommodation for all members of the residence, if possible.
- Wait for an Evacuation Order to be issued before evacuating. Monitor [news/radio/online source] for information on evacuation orders and location of Reception Centres.

Further information will be issued by [Chief and Council daily] with direct calls coming from Moon Moore Councillor-Emergency Management Portfolio
