WHEREAS Chawathil First Nation is currently under threat of flooding due to the atmospheric river impacting the Fraser Valley region, resulting in imminent danger to the health and safety of community members residing in low-lying areas;

AND WHEREAS Chawathil Council has identified that the following properties are at high risk of flooding and require immediate evacuation to ensure the safety of occupants:

- 16-60990 Jackson Avenue, Hope, BC

AND WHEREAS emergency response measures, including evacuation and temporary relocation, are authorized under Chawathil First Nation's Emergency Management Authority in collaboration with Emergency Management BC and other relevant agencies;

THEREFORE BE IT RESOLVED THAT:

- Chawathil First Nation Council hereby issues an Evacuation Notice for the above addresses effective immediately, December 12, 2025.
