



## EVACUATION ORDER

Ocean Falls, British Columbia

Date: March 18, 2026

Whereas a state of local emergency was declared on March 18, 2026, by the Central Coast Regional District pursuant to Section 95 of the *Emergency and Disaster Management Act* due to landslide hazard risk within the area of the hamlet of Ocean Falls, British Columbia, in Electoral Area A.

And whereas Section 107 (1)(c) and (d) of the *Emergency and Disaster Management Act* authorizes requiring evacuations in relation to a declared state of local emergency, making arrangements for the adequate care and protection of evacuated persons and animals, and controlling travel to or from an area;

And whereas the landslide hazard risk is a significant threat to the health, safety, and welfare of persons, such that an evacuation and controlling travel are necessary to minimize threats;

This **Evacuation Order** has been issued by the Central Coast Regional District and is **effective as of** March 18, 2026, for the area outlined in the map below.

### **YOU MUST LEAVE THE AREA IMMEDIATELY**

Members of the RCMP and Westcoast Marine Services will be expediting this action.

The evacuation route is from Fifth Street along Bennet Street, Lewthwaite Street or Marine Drive toward Front Street.

A person must not enter any of the area(s) identified above and in the attached map for purposes of residing, occupying, or visiting the area(s).

## **WHAT YOU SHOULD DO:**

- If you need transportation assistance from the area, advise the person providing this notice or call 250-982-0062.
- If you have homeowners' or tenants' insurance, contact your insurance provider to arrange for living expenses such as accommodation and food.
- Close all windows and doors.
- Gather your family and, if you have room, take a neighbour or someone needing transportation.
- Take critical items (e.g., medicine, wallet, insurance policy number/contact) only if they are immediately available. Take pets in pet kennels or on leash.

## **EMERGENCY SUPPORT SERVICES:**

- Residents who require assistance from government to meet their basic needs during the evacuation are asked to register for Emergency Support Services (ESS).
- Evacuees may request and register for support at:

- Upon request and based on assessed need, temporary accommodation and meals may be provided through the Emergency Support Services program.
