RECIND EVACUATION ORDER TO EVACUATION ALERT

**WHEREAS**, a State of Local Emergency has been declared by St’uxwtéws due to the Pear Lake Wildfire (C40983); and

**WHEREAS** the Pear Lake Wildfire poses an immediate and significant threat to the life, health, safety, and well-being of residents and all persons within the affected area; and

**WHEREAS** emergency conditions may change rapidly and require immediate action to protect public safety;

**THEREFORE, BE IT RESOLVED THAT**, a RESCIND Evacuation Order for Loon Lake IR #4 is now moved to an EVACUATION ALERT hereby issued and is effective immediately for all persons residing in, occupying, or otherwise present within the designated evacuation order area.

**BE IT FURTHER RESOLVED THAT**, all persons within the designated evacuation order area must leave immediately and proceed to a safe location as directed by emergency authorities.

**BE IT FURTHER RESOLVED THAT**, residents are advised not to delay evacuation, as wildfire conditions and associated hazards may change rapidly and without warning.

**BE IT FURTHER RESOLVED THAT**, this Evacuation Order shall remain in effect until rescinded or amended.
